Motion and Decision on Personnel Matter

Chairman Elliot stated that the District and Kevin Strickler have agreed to a \$88,000 settlement; \$73,000 in lost wages and benefits and \$15,000 for the attorney fees for Mr. Strickler's counsel. The District's insurer is paying the full \$88,000. The District will be responsible for the employer taxes which is estimated to be between 5 and 6 thousand dollars.

Trustee Sheehy moved to ratify the financial terms of settlement between Mr. Strickler and the District's insurer and direct preparation of the processing of the settlement through the District's payroll system and the Board, if necessary, to authorize Acting Chief Greg Tryon to sign the general release and settlement agreement on behalf of the District. Trustee Varley seconded the motion. The motion was unanimously approved.
